The **Government of Pakistan** has received financing from the World Bank towards the cost of Balochistan Integrated Water Resources Management and Development (BIWRMDP) and intends to apply part of the proceeds toward eligible payments under the contract for production of plants through raising of nurseries in three identified places located at Harnai, Dhadar and Uthal.
1. The Project Director, Balochistan Integrated Water Resources Management and Development (BIWRMDP) now invites interested/eligible Offerors to submit their priced quotation(s) as per BOQ and specifications contained in the Document titled "Request for Quotation (RFQ)" that may be purchased by upon submission of a written application to the address below and upon payment of a nonrefundable fee of Pak Rupees 1,000/- (In words Rupees One Thousand Only) to be credited in Government of Balochistan's Non-Food Account No. 01 (Head of Accounts 03434) through green bank challan. The RFQ can also be dispatched through courier but charges will be borne by the Recipient.
2. Offeres must quote for all the items to offer their best competitive price considering that all inland taxes will be charged at admissible rates. Quotations will be compared, evaluated and contract will be awarded to one offering the lowest evaluated total price and that meets the eligibility criteria. The scope of works comprised of three distinct lots corresponding to each location. It is, however, at liberty of the prospective offeres to Quote either for one or all lots.

Offeres will be conducted through the Shopping procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers (January 2011) (Revised 2014) ("Procurement Guidelines"), and is open to all eligible offerors as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
