1.	Procurement Specialist	Master Degree (sixteen years of education) in Engineering/Business/ Economics & Finance or Commerce/Social Sciences with seven (7) years of experience (after acquiring stipulated qualification) in procurement and contract management at least five years of which should related to procurement of Goods, Works and Consulting Services preferably in development sector.
2.	Environmental Safeguards Specialist	Master's Degree in Environmental Sciences or MS in Environmental Management/ Natural Resource Management/ Environmental Engineering. Ten (10) years of professional post qualification working experience in public/private organizations, preferably in development sector.
3.	Social Safeguards Specialist	Master's degree in Sociology, Anthropology, Rural Development or Agriculture Economics. 10 years of post qualification relevant working experience. Experience in community driven development projects with international lending agencies will be preferred. Familiarity with social safeguard policies of international lending institutions, especially the World Bank.
