

INVITATION FOR BIDS (IFB)

1. The **Government of Pakistan** has received a credit No. 58850-PAK from the International Development Association (IDA) towards the cost of Balochistan Integrated Water Resources Management and Development Project (BIWRMDP) and intends to apply part of the funds to cover eligible payments under the Contracts for following works:

Besides, the World Bank's policy on conflict of interest as set forth in paragraphs 1.6 and 1.7 of the mentioned Guidelines is worth considering for the prospective bidders.

1. The **Project Director, BIWRMDP** invites sealed bids from eligible bidders for the Works of Construction of above mentioned schemes. Interested bidders may obtain further information and/or inspect the bidding documents during office hours i.e 9.00 to 16.00 hours at the address given at the end of this invitation or mailing at bssip@yahoo.com. This Invitation to Bid along with Bidding Documents is being simultaneously uploaded on BPPRA Web Site

Bidding documents (and additional copies) in English may be purchased by interested/eligible bidders upon submission of a written application accompanied by evidence of payment of Rs. 3,000/- (non-refundable) being the cost of one set of Tender Documents to be credited in Treasury through Green Challan (Head of Account C-03434) in favour of the Project Director, Balochistan Integrated Water Resources Management and Development Project. The Bidding Documents can also be dispatched through courier but charges will be borne by the recipients.

3. Bids must be delivered to the address at the end of this invitation on or before 12:00 Noon on the dates mentioned against each scheme in the above table Electronic bidding will not be permitted. Late bids will not be considered. Bids will be publicly opened on due dates in the presence of the bidder's designated representatives and anyone who choose to attend at the address mentioned at the end of this invitation immediately after 12:00 Noon.
4. All bids must be accompanied by a Bid Security in Pak Rupee equivalent 2% of the offered bid price and in form given in the Bidding Data contained In Bidding Documents Volume - I
5. The method of procurement will be the **International Competitive Bidding (ICB)** for the contract mentioned at Sr. No. 1 and **National Competitive Bidding (NCB)** for the contracts mentioned at Sr. No. 2 and 3 in accordance with World Bank's Procurement Guidelines referred to above.
6. A pre-bid conference (for ICB Contract only) will be held at 11:00 hrs on 10th December 2019 at the address given below. The purpose of the meeting will be to clarify site and various other issues and to answer the questions on any matter that may be raised at that occasion.
