A Data Centre shall be established at Quetta under a separate contract (Package 2 of 2) of Phase-I. Accordingly the intended equipment for Lot 1 & Lot-2 shall be synchronized with Data Centre through SaaS applications for data collection and management.	

3. Bidders are allowed to bid complete quantities of one or both lots. Evaluation and award shall be on the basis of lots. Bidding will be conducted through international competitive procurement using International Competitive Bidding (ICB) procedures defined in the World Bank's Guidelines: Procurement of Goods, Works and Non-consulting Services under IBRD Loans and IDA Credits and Grants by World Bank Borrowers dated January 2011 revised July 2014 ("Procurement Guidelines") and open to all eligible Bidders as defined in the Procurement Guidelines.

- 4. Interested/eligible Bidders may obtain further information from Office of the Project Director, Balochistan Integrated Water Resources Management and Development Project (BIWRMDP) at the address given below.

- 6. Bids must be delivered at the address below on or before 12:00 hours on **4**<sup>th</sup> **February 2021.** Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives or any one who chooses to attend at 12:30 pm on the same day at the address given below.
- 7. Due to Covid-19 outbreaks, physical pre-bid conference will not be held. Project will however organize a virtual session on 11<sup>th</sup> January 2021 at 12.00 noon where a detailed presentation will be given for helping bidders to submit a bid free of errors and to respond queries. Additionally, any questions/queries may be delivered to the postal and email address given below in writing at least 10 days before the deadline for submission of bids.
- 8. All bids may be accompanied by a "Bid Security" in the form of an unconditional Bank Guarantee or CDR issued by a Schedule Bank of Pakistan in an amount of 2% of the Bid Value. This should remain valid 28 days beyond bid validity period.
