9. BIDDING PROCESS

9.1. Preparation & Approval of Bidding Documents

The Bidding Documents were prepared by using the 2017 version of the Standard Bidding Documents provided by the World Bank. The Bidding Documents were approved by the Bank on May 17, 2017.

9.2. Contents of Bidding Documents

The Bidding Documents comprises of three volumes. Volume I contains Bidding Procedures, Works Requirements and Contract Conditions & Contract forms. Volume II comprises of specifications of items of works contained in the works requirements and Volume III comprises of Bid Drawings.

9.3. Amendments to the Bidding Documents

One addendum to the Bidding Documents was issued on June 21, 2017. Through this addendum, the text "1st January [insert year]" in Clause 4.2(a) of Section III – Evaluation & Qualification Criteria was replaced with "1st January 2007".

9.4. Invitation to Bid

The Invitation to Bid was published in local and national newspapers on May 24, 2017. The notice was also published in UNDB online, website of BPPRA and project website on May 23, 2017.

9.5. Date of Bidding Documents available for Sale

The Bidding documents were made available for sale to interested bidders from May 25, 2017 soon after the publication of invitation.

9.7. Pre-Bid Meeting

According to the provisions of Bidding Documents, a pre bid meeting was held on June 19, 2017 as per ITB 7.4 of Data Sheet to clarify any issues and to answer questions on any matter that may be raised by the contractors. A short presentation was made by the project authorities followed by a detailed review of Bidding Documents and question answer session.

9.8. Date and Time of Bid Opening

As per provisions of Bidding Documents, Bids were received till 14:00 hours of July 10, 2017. The bids were opened on the same day in the presence of representatives of all the Bidders and the members of the Bid Evaluation Committee at 15:00 hours.

10. BID RESPONSE AND EVALUATION RESULTS

10.1. Read Out Bid Prices

Six (06) Bidders submitted their bids and these were opened in the presence of the bidders' representatives at the due date and time.

The names of the bidders, the total bid prices and the bid security mode/amounts were read out loudly for the information of prospective bidders present. Immediately following the opening of bids, the status of bids received was drawn up as presented in following tables.
